PUBLIC NOTICE FOR NRI/OCI/PIO

This is for information of all candidates seeking admission to MBBS/BDS Courses in Government/Government Aided/Private Medical and Dental Educational Institutions in the State of Haryana including those under Private Universities-SGT University, Budhera, Gurugram, Maharishi Markandeshwar University, Sadhopur, Ambala, Al-Falah University (Minority Private University) and Sanskaram School of Medical Sciences, Jhajjar under Sanskaram University for Academic Session 2026-27 under NRI quota are advised to go through the Govt. of Haryana Notification No. 16/10/2024-6HBIV dated 27.08.2026 carefully regarding eligibility criteria and other details. The following documents are required for NRI/OCI/PIO Category Candidates.

1. Copy of the Passport of Candidate/Parent/ Sponsorer as the case may be.
2. Documentary evidence/ Certificate of NRI/OCI/PIO/ Foreign national as per Govt. of India instructions issued from time to time (As applicable).
3. Sponsorship affidavit from NRI/OCI/PIO stating that sponsorer will bear all the expenses for the whole duration of study of the candidate (if applicable).
4. The sponsore, of the candidate of Category VI (1st Degree as described in Govt. Notification) should have looked after such student as the guardian of the student and evidence to that effect must be produced by such person.
5. Relationship affidavit (Relation of candidate with the sponsorer alongwith family tree and supportive documentary evidences in form of Passport/PAN Card / Aadhar Card/ Ration Card/ 10th- 12th certificates etc).
6. Provisional tuition fee should be paid only through the NRE/NRI/NRO/Foreign bank account of Candidate/Parent/Sponsorer (as the case may be) through admission Web Portal only. Amount can also be paid in equivalent INR.
7. Proof of NRE/NRI/NRO/ Foreign Bank Account with statement.
8. Candidates who are provisionally allotted seats have to deposit "provisional tuition fee" through admission web portal only. After successful document verification at Pt. B.D. Sharma University by admission committee, the candidate will be issued provisional admission letter on admission web portal and the candidate will have to submit joining report in the concerned college as per schedule.
9. Candidates applying under NRI category as per the Govt. of Haryana Notification Haryana Notification No. 16/10/2024-6HBIV dated 27.08.2026 should ensure that they strictly fall under the categories as mentioned in the Notification and have documentary evidence to support their claim failing which the allotted seat would be cancelled.

Please note that, due to non-availability of any of above mentioned documents at the time of document verification, the candidature of NRI candidate will not be considered AND THE PROVISIONALLY ALLOTTED SEAT TO THE CANDIDATE WILL BE CANCELLED.
