CORRIGENDUM

Reference e-tender notice No. PGIMS/Cell-III/20/1031 dated 05.03.2020 & Tender ID. 2020_HRY_122282_1 for Sanitation Services at UHS, Rohtak with the last date of submission/receipt of e-tender is 07.04.2020 upto 1.00 PM and opening date is 07.04.2020 at 03.00 PM. Following changes are to be incorporated in the e- tender document, as per the decisions taken in the pre-bid meeting held on date 19.03.2020 at 03:00 PM:-

- I. The minimum cost of consumable materials and machinery quoted by the firm shall be more than 5% of the basic wage component only or in case of less charges quoted by any bidder, then the bid will be rejected. No material and machines charges shall be paid on statutory component (i.e. EPF/ESI etc.). The material and machinery charges quoted by the firm by more than two decimal points shall not be accepted." And the format of Price bid mentioned at Annexure-VIII of tender document shall be included in a column regarding cost of consumable material.
- II. Financial/Price Bid (at Annexure-VIII) may be uploaded in the XLS format (Excel Sheet).
- III. Evaluation Methodology Quality cum Cost Basis Selection Criteria for e-tender of Sanitation Services at "Annexure-VII" needs elaboration to avoid any ambiguity as mentioned below:-
 - (i) Average Annual Turnover This point is clear and no needs for further clarification.

 (for the last 03 years)
 - (ii) Average Profitability It is clarified that Profitability before tax should be considered.

 (for the last 03 years)
 - (iii) Experience It is clarified that for the purpose of marking the experience in the industry will be counted instead of experience as per eligibility criteria.
 - (iv) Average No. of Govt. Clients It is clarified that for the purpose of marking all type of Govt. contract should be considered instead of as per eligibility criteria.
 - (v) Average Manpower It is clarified that for the purpose of marking average manpower of the company should be considered instead of as per eligibility criteria.
- IV. The title of Sanitation Services tender may be reframed and substituted as under:-
 - "(a) Deployment of any agency or (b) Coop. Labour and Construction Societies consisting of all Scheduled Caste members for providing mechanized Sanitation Services for one year which is extendable on quarterly basis to a maximum of another one year subject to satisfactory services at University of Health Sciences (UHS), Rohtak."
- V. The financial score formula given on Page No. 32 shall be substituted as under:"Financial Score = (7.41/bid figure)*100"
- VI. The last date of submission/opening of e-tender may be extended for two weeks i.e. 07.04.2020 to 21.04.2020 with same time of submission and opening as mentioned earlier in the tender documents due to lockdown of the country for 21 days (upto 14 April 2020) for crisis of COVID-19.
