- 4. The candidates are required to bring demand draft of Rs.20,000/- on account of provisional tuition fee in favour of "Controller of Finance, Pt.B.D. Sharma UHS, Rohtak". It is for the information of all the registered candidates desirous of seeking admission to M. Pharmacy Courses for the Academic Session 2024-25 in Constituent and Pvt. Pharmacy Institutions affiliated to Pt. B.D. Sharma University of Health Sciences, Rohtak that the following documents to be brought at the time of document verification before Admission Committee on 28.11.2024 - Round-III (Mop-up):-

- 1. Matriculation Certificate/High School/ICSE/Class X/Class XII or its equivalent certificate as proof of date of birth.
- 2. Three copies of the recent photographs (passport size) self attested.
- 3. Character certificate of the Head of Institution last attended/First Class Executive Magistrate.
- 4. Resident certificate issued by competent authority of the State Government of Haryana (bonafide resident certificate issued by the competent authority of the State Government (if applicable).
- 5. Caste Certificate issued by competent authority of the Haryana State Government (if applicable).
- Creamy / Non-Creamy certificate for BC-A / BC-B category candidates as per Govt. of Haryana notification dated 16.07.2024, certificate for the year 2024-25 and issued on or after 01.04.2024 should brought at the time of physical document verification (if applicable).
- 7. Aadhar Card/PAN Card/Driving License/Passport/Voter ID/Ration Card/Parivar Pehcahan Patra as proof of identification.
- 8. For candidates with CGPA grades, a certificate must be provided that includes the conversion factor from respective Universities, without this his/her candidature will not be considered.

Note:

Any candidate, who fails to produce any of the required certificate/document at the time of document verification in person, shall loose his/her claim to admission.
