It is for the information of all the eligible candidates desirous of seeking admission to various Nursing, Physiotherapy and other Paramedical courses for the Academic Session 2021-22 that counseling shall be conducted through Online Combined Centralized Counseling for all Government/Private Unaided Nursing/Physiotherapy/Paramedical Institutes in the State of Haryana on the basis of merit list prepared as per the marks obtained in the CET 2021. 2. Detailed schedule of documents verification will be uploaded separately on admission portal & university website.

The personal appearance of the candidates who have been provisionally allotted seat along with all original documents in front of the Admission committee at (Committee Room Director Office Pandit Bhagwat Dayal PGIMS, Rohtak) is mandatory failing which his / her candidature will not be considered.
4. Any amendments by the State Government / Government of India, Ministry of Health & Family Welfare / INC / Haryana Nursing Council shall be applicable.
5. Admission shall be made to only those institutes which are approved / recognized for admission by statutory body and who have obtained consent of affiliation from the concerned University in accordance with the last date as prescribed by Government of India / State Government.
6. **ANY ADMISSIONS MADE BY ANY PRIVATE NURSING / PHYSIOTHERAPY / PARA MEDICAL COLLEGES IN THE STATE AT ITS OWN LEVEL SHALL NOT BE VALID AND SUCH ADMISSION SHALL BE CONSIDERED AS NULL AND VOID.**
