All candidates who have been allotted seats provisionally in Mop Up Round for admission to PG Courses for the Academic Session 2020-21 are instructed to bring their original certificates & other relevant documents for verification for production before the admission committee. Physical presence of the candidate is compulsory. No undertaking will be entrained against any document. The candidates shall have to deposit the original documents & fee in the shape of Demand Draft in favour of "Counseling and Admission on A/C for Deptt. of Medical Education & Research (DMER)" Name of Bank : ICICI Bank Ltd. Account No. :073205002133 IFSC Code No.: ICIC0000732 to the Admission Committee at the time of Mop Up round as notified below failing which their candidature shall not be considered.

For admission in Govt./Govt. Aided Institutions - Complete fee as per Notification dated 15.04.2020.

For Admission in Pvt. Institutions including those under Private Universities –

For MD/MS/MDS Courses - Atleast 50% of Tuition Fee/ Course Fee is to be deposited at the time of counseling to the Admission Committee.
- Remaining tuition fees will have to be deposited in the college concerned.

For the convenience of the candidates, the candidates are allowed to submit multiple demand drafts as per their convenience considering different fee in Govt./ Govt. Aided/Private institutes the fee in all institutes has already been notified in the notification 15.04.2020.

Unfilled PWBD Category seats after giving opportunity to the category candidates will be converted to ESM/DFE will be filled up as per State Govt. Policy in Mop Up Round.

The unfilled seats reserved for category candidates (SC/BCA/BCB/EWS etc.) in Govt./Govt. Aided Medical/Dental Institutions will be converted only after giving compete opportunity to the students of respective category in stray round.

Refund process will be started after the counseling process is over.
