**Note 1:-** The point No. 3.3 of Govt. Instructions No. 22/12/2019-IGS-III dated 25.02.2019 reproduced below for information of the aspirants:-

“Where in any recruitment year any vacancy earmarked for EWS can not be filled up due to Non availability of suitable candidate belonging to EWS, such vacancy for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from Unreserved Category”.

**Note 2:-** As per Govt. instruction dated 13.11.2024, if and only if suitable candidates of Deprived Scheduled Castes (DSC) are not available, then suitable candidates of Other Scheduled Castes (OSC) may be recruited against the balance vacant posts and vice-versa.

**Abbreviations:** UR-Unreserved, DSC-Deprived Schedule Caste, OSC- Other Schedule Caste, BC- Backward Class, EWS- Economical Weaker Section, ESM-Ex-Servicemen & PwD- Person with Disability.

**Application Fees:-**

The candidate must submit application fee through a crossed **Demand Draft** in favour of the Controller of Finance, Pt. B. D. Sharma University of Health Sciences, Rohtak. The application fee is **Rs. 1000/-** for General Category and **Rs. 250/-** for Reserved Categories (for Haryana Domicile only). 50% concession in the above fees is granted to the women candidates (both General and Reserved Category) as per Govt. Instructions. **PwD & ESM candidates are exempted from the application fee.**

**QUALIFICATION & EXPERIENCE:**

**SENIOR RESIDENT (Medical)**

1. MBBS from Institution/University recognized by the MCI.
2. MD/MS/DNB in the subject concerned.
3. Must be registered under the State/Central Medical Registration Act.

**SENIOR RESIDENT (Non- Medical)**

In the subjects of Anatomy, Biochemistry, Physiology, Pharmacology and Microbiology candidates possessing M.Sc (Medical) and P.hD (Medical) – (Regular Mode/Campus Course recognised from Medical Institution) qualifications in the subject concerned are eligible to apply.

**TUTORS**

1. MBBS from Institution/University recognized by the MCI.
2. Must be registered under the State/Central Medical Registration Act.

**DEMONSTRATOR (Non-Medical)**

In the subject of Biotechnology & Molecular Medicine candidate possessing M.Sc (Medical) and P.hD (Medical) -(Regular Mode/Campus Course recognised from Medical Institution) qualifications in the subject concerned are eligible to apply.

**Pay Scale of Senior Residents (Medical)**

Rs. 67,700+ 13,540 NPA+DA (admissible as allowed by the Govt. from time to time) to MD/MS/DNB Degree Holders

**Pay Scale of Tutor**

Rs. 56100+DA for MBBS.

**Pay Scale of Senior Residents/Demonstrator (Non-Medical)**

Rs. 67,700 + DA (admissible as allowed by the Govt. from time to time) to PhD Degree Holder.

### Age:

The age for the posts of Senior Resident, Demonstrator and Tutor must be below 45 years of age except in the subjects of Anatomy, Biochemistry, Physiology, Pharmacology, Microbiology, Pathology, Forensic Medicine and Community Medicine, the upper age-limit shall be 50 (fifty) years as on the closing date of submission of application.

The Benefit of relaxation in upper age in respect of candidates belonging to SC/ST, BC, ESM etc. will be as per Haryana Govt. instructions issued from time to time and is restricted to Haryana Domiciles only.

### General Terms & Conditions

1. Number of posts is liable to increase or decrease either way, including complete withdrawal without assigning any reason.
2. No separate interview letter will be sent and no TA/DA will be paid for attending the scrutiny/interview. All information relating to this advertisement may be seen on university website [www.uhsr.ac.in](http://www.uhsr.ac.in).
3. The applicants must fill the required data additionally on the given URL:- <https://forms.gle/Mx98CC2jvkzEWjs8A> OR SCAN given here.
4. The following documents in original are to be produced at the time of scrutiny/interview:-
  - a. 10<sup>th</sup> Class Certificate as proof of Date of Birth.
  - b. Certificate for proof of reservation category, if applicable.
  - c. MBBS, MD/MS/DNB Post-Doctoral Degrees.
  - d. Attempt certificate during various Degree/Diploma programme.
  - e. MCI (now NMC) or State Medical registration certificate.
  - f. Certificate of additional qualifications where applicable.
  - g. Experience Certificate.
  - h. Research publications along with proof of indexing status of the journal in which the research article has been published.
  - i. Certificate of presentation of the research article at a conference.
  - j. Sports certificate for prize or position in an international/national/inter university sports or athletic meet.
  - k. College Colour Certificate for Sports.
  - l. Any other certificate.



The above mentioned documents {(Sr. No. 4(c) to 4(l)} are required to calculate the pre-merit as per Selection Criteria attached at Annexure-'B'.

5. Separate application form may be submitted for separate post.
6. Those applicants who are doing MD/MS/DNB/M.Ch/PhD course, on selection as Senior Resident/Tutor will have to discontinue their MD/MS/DNB/M.Ch/PhD Course before joining the post.
7. Where there is a shortage of Senior Resident/Demonstrator/Tutor (Medical) and eligible candidates are not available, the candidates, who have completed one tenure of three years, can be considered for second tenure.
8. The applicants who are already in Govt./Semi Govt./Corporation or Autonomous Body Service should sent application through their respective Head of the Institute or bring fresh 'No Objection Certificate' at the time of interview failing which the applicant will not be allowed/considered for interview, **NOC may not be older than three months.**
9. Mere submissions of the application and call for interview does not means that the aspirant is eligible for the post applied for. The eligibility shall be verified before the interview as per the qualifications, experience and other terms and conditions given in the advertisement.
10. 4% percent of the posts (Medical) shall be reserved for person's with disability (PH category). A person who wants to avail of the benefit of reservation would have to submit a Disability

Certificates issued by a Competent Authority on prescribed format as notified by the Govt. from time to time.

11. In case any applicant belonging to Scheduled Castes or Backward Classes or any reserved category applies against General Category post, he/she must fulfill the conditions of the eligibility regarding age, qualification & experience and application fee etc. as are meant for General Category candidates.
12. The candidates who belong to DSC/OSC, BC-A/BC-B categories must submit their caste certificate as per Govt. of Haryana notification issued from time to time.
13. In case any discrepancy is detected in the document submitted by the applicant or in the process of selection, at any stage even after the issue of appointment order, the University reserves all the rights to modify/withdraw/cancel any communication made to the applicants.
14. The decision of the appointing authority in all matters relating to acceptance or rejection of application, eligibility/suitability of the applicants, mode and criteria for selection etc. shall be final and binding on the applicants.
15. All disputes pertaining to the recruitments of various posts shall fall within the jurisdiction of Rohtak only.
16. The prescribed qualification, experience and age etc. shall be reckoned as on the closing date of submission of applications.
17. The degrees of undergraduate/postgraduate not recognized by the NMC (erstwhile MCI)/UGC shall render the applicant ineligible for said post.
18. Any change in the category mentioned in the application form after the closing date/time of submission of application form will not be allowed.
19. Submission of incomplete application and those applications received after the closing date & time will not be entertained. This University will not be held responsible for any postal delays & loss of application and the fee shall be forfeited. Fee of the candidates found not eligible shall also be forfeited.
