Furthermore, the student who could not fill their examination form for appearing in 7<sup>th</sup> semester examination (2023 LEET, 2022 and previous eligible batches) opened from 01.04.2026 to 20.04.2026 may also fill the examination forms according to the above mentioned schedule through online portal <https://uhsrexam.com/>, failing which the student(s) will not be allowed to appear in the examination.

In case the students who have already applied for the examinations, they are not required to fill the examination forms again.

Subject: Provisional Eligibility for upcoming 7th Semester B.Pharmacy Examination

This is to inform all concerned that the results of the B.Pharmacy 3rd and 4th Semester Supplementary Examinations are currently delayed. To avoid further disruption in the academic schedule and to safeguard students' career progression, it has been decided as follows:

Provisional Eligibility:

Students who appeared in the recent 3rd and 4th Semester Supplementary Examinations may be provisionally allowed to appear in the upcoming 7th Semester examination.

Condition for Provisional Eligibility:

Each student must submit a written undertaking to their respective Principal, stating that:


"If they fail the 3rd or 4th Semester Supplementary Examination, their 7th Semester examination attempt will be considered null and void, and no result will be declared for that attempt."

This decision has been taken to prevent further delays in the 7th Semester examination and to ensure timely conduct of the 8th Semester examination, which is essential for students appearing in M.Pharmacy entrance examinations or applying for job opportunities.

Tentative Schedule of 8th Semester Examination:

The 8th Semester examination will be conducted in the first week of July 2026, without any further delay. Please complete all the eligibility requirements at the earliest.
