Applications are invited from eligible Medical Graduates to fill up the 153 vacant posts of Senior/Junior House Surgeons carrying the emoluments of Rs. 56100+DA in FPL-10 according to 7th CPC as per approval of Haryana Govt. for a period of six months only i.e. for the session from **01.07.2026 to 31.12.2026** in various departments of this institution. The prospective candidates should apply on the prescribed proforma obtainable from the counter of the office of the Director (Accounts Branch) @ of Rs. 500/- for General Category and Rs. 125/- for SC/BC etc. of Haryana Resident.

Application duly completed in all respects with contact telephone number, must reach the office of the undersigned by **05.06.2026 up to 05:00 PM sharp**. Applications received after the stipulated date and time will not be entertained. All the candidates are required to appear for document verification on **19.06.2026 at 09:00 AM** and for counselling/interview on **19.06.2026 at 12:00 Noon** in the office of the undersigned. In case **19.06.2026** is declared as holiday, interview will be held on the next working day. It is also added that the 2nd counseling will be held on **07.07.2026** for vacant seats, if any. No separate interview letters will be sent for the same. At the time of interview, the original documents shall have to be produced. A CANDIDATE MUST HAVE THE FOLLOWING QUALIFICATIONS.

1. Must have passed M.B.B.S from a Medical College/Institute recognized by the NMC.
2. Internship must have been completed by **30.06.2026**.
3. Permanent registration certificate from Haryana Medical Council. The candidates, who passed the MBBS & completed the internship recently and not registered with Haryana Medical Council, may submit an affidavit that they will apply for registration in Haryana Medical Council and submit the Haryana Medical Council Certificate within one month of the date of joining, failing which they will not be paid their salary and their service may be terminated without any notice. The candidates, who has registered in any other State Medical Council must submit the NOC certificate along with the proof of application for Permanent Registration in Haryana Medical Council.

NOTE: - ON FOLLOWING TERMS & CONDITIONS: -

1. The selected candidates will have to deposit the security as 50% of the basic salary, which is refundable security for each session exclusively and separately for House Job. The selected candidates who fails to deposit the security money, their appointment will be cancelled without assigning any reason.
2. The candidates selected in 1st counseling who do not join the allotted deptt. within 3 days of issuing of the appointment letter will not be considered for the 2nd counseling.
3. The candidates who remain absent willful for more than 07 days, his/her services shall be terminated, and no opportunity will be allowed for re-joining during that session.
4. Incomplete application forms will not be entertained and will be rejected.
5. That the resignation tendered by the House Surgeon will be considered, if there is any genuine reason with 15 days advance notice or after depositing 15 days salary.
6. The security money deposited by the House Surgeon who leaves the session before the end of Six months duration will be forfeited and No Experience be issued in that case.
7. The other terms & conditions will remain the same as provided by the prescribed proforma of the application form.
8. The vacancies falling vacant and on account of resignation / termination etc. will be displayed on the notice board as well as the website of institute.
9. The benefit of reservation will be given only to those DSC / OSC / BC-A / BC-B / EWS / PwBD / ESM category candidates, who are domiciles of Haryana State.
10. The candidates belonging to BC-A/BC-B categories are required to obtain the **fresh/latest BC-A or BC-B certificate**, as the case may be, as per Haryana Government instructions No. 22/132/2013-1GS-III dated 22.03.2022, Government notification no. 40/13/2024-1SW dated 16.07.2024 and as amended from time to time. This certificate should be issued in the **year 2026-27**. **Old certificates will not be considered. Only BC-A or BC-B certificate** as per instructions detailed above shall be considered. **OBC certificate** shall not be entertained. The candidates who belong to EWS category are required to submit the **EWS certificate of Current Financial Year i.e. 2026-27**.
11. The candidates applying for the above posts must ensure that they fulfil all the eligibility criteria for the post applied for on or before the crucial date, i.e., the closing date for receipt of application forms (**05.06.2026**). In case a candidate does not fulfil the requisite prescribed qualification or reservation criteria on or before the crucial date, i.e., the closing date for receipt of application forms (**05.06.2026**), his/her candidature shall be rejected outrightly.
12. If on verification at any stage starting from submitting application form till appointment and any time even after appointment, it is found that any candidate does not fulfill any of the eligibility condition or it is found that the information/document furnished is false or incorrect, his/her candidature will be cancelled and service will be terminated without any notice.
13. During the process of this recruitment, the possibility of inadvertent or technical errors cannot be ruled out. The Office reserves the right to rectify the same at any stage, if detected later on.
