- Must have passed M.B.B.S from a Medical College/Institute recognized by the NMC.
- 2. Internship must have been completed by 30.06.2025.
- Permanent registration certificate from Haryana Medical Council. The candidates, who passed the MBBS & completed the internship recently and not registered with Haryana Medical Council, may submit an affidavit that they will apply for registration in Haryana Medical Council and submit the Haryana Medical Council Certificate within one month of the date of joining, failing which they will not be paid their salary and their service may be terminated without any notice. The candidates, who has registered in any other State Medical Council must submit the NOC certificate along with the proof of application for Permanent Registration in Haryana Medical Council.

## NOTE: - ON FOLLOWING TERMS & CONDITIONS: -

- 1. The selected candidates will have to deposit the security as 50% of the basic salary, which is refundable security for each session exclusively and separately for House Job.
