#### Revised Public Notice (Round-2)

### In supersession of Public Notice bearing No.UHSR/Acad./A-1/2025/9082 dated 04.11.2025,

Admission to Nursing – Irregular Batch (B.Sc. Nursing), Physiotherapy (BPT/MPT) and Paramedical courses in Government and Private Institutions affiliated to Pt. BD Sharma UHS Rohtak for the Academic Session 2025-26.

It is for the information of all the eligible candidates desirous for seeking admissions to Nursing, Physiotherapy and Paramedical courses in Government and Private Institutions affiliated to Pt. BD Sharma UHS Rohtak located in the State of Haryana that the State Government will be conducting Online Combined Centralized Counseling (Round-2) for the Academic Session 2025-26 on the merit of CET-2025 conducted by Pt. BD Sharma UHS, Rohtak for the following courses: —

The detailed process explaining the procedure for admission to the above mentioned courses has been notified by the State Government dated 08.08.2025 and can be downloaded from the Admission Web Portal i.e. <a href="https://uhsrcetadmissions.in">https://uhsrcetadmissions.in</a>, University Website i.e. <a href="https://uhsrcetadmissions.in">www.uhsr.ac.in</a>. All the eligible CET-2025 qualified candidates are required to register themselves online through admission web portal. The tentative schedule of Round-I of counseling is as under:-

## Note:-

- a) Fresh candidates can register for Round-2 of counseling if not registered in Round-1.
- b) The candidates, who have already registered themselves for the Round-1 and wish to participate in the Round-2, shall not be required to register again.
- c) The candidates, who have been allotted/joined seats in the Round-1 of counseling shall have to give their willingness/option to upgrade themselves in the Round-2 of counseling online otherwise they shall not be considered eligible for the Round-2 of counseling.

- d) The Candidates, who have joined on the allotted seat in the Round-1 shall have a right to already allotted seat and this shall be changed only if, he/she gets an upgraded opted seat during Round-2. However, the candidates who wish to participate in the Round-2 of online counseling will have to submit their preferences/choices afresh. Candidates, who have joined, seat in Round-1 should give the fresh choices in order of preferences for the seats in which they wish to upgrade.
- e) All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Round-2 of counseling and want to opt for State Quota Seats in only Government Nursing/ Physiotherapy/ Paramedical Colleges shall be required to deposit online Security amount of Rs. 1,000/- if the candidate wishes to also opt for State Quota Seats and for Management Quota Seats in private Nursing/Physiotherapy/Paramedical Colleges then he/she shall have to deposit online an security amount of Rs. 5,000/-. This facility shall be available in the login ID of the candidates on admission web portal. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Round-2 of counseling. This facility shall be available in the login ID of the candidates on admission web portal.
  - Security amount shall be adjusted in the tuition fee of first year of course, after the candidate joined on the allotted seat.
  - In case of failure of any registered candidate (whether freshly registered or the candidates who have joined seats in the Round-1 and want to upgrade their seat in the Round 2) to deposit the requisite security amount, they will NOT be considered eligible to participate in the Round-2 of counseling.
  - If the candidates are allotted any seat as per their preference, but they do not join on the allotted seat, the **security amount shall be forfeited**. However, these candidates will be eligible to participate in the Round -3 after forfeiture of previous security amount and deposition of fresh security amount.
  - The security amount of the candidates who are not allotted any seat during the Round 2/Round-3 shall be returned after the completion of the counseling process.
  - The candidates who join on the allotted seats in the Round-2 of counseling, will be eligible to participate for Round-3 of counseling.
  - Any candidate who had joined in Round-1 but do not participate in Round-2 counseling or do not resign from the Round-1 joined seats, will also be allowed to participate in Round-3 after deposition of security amount.
  - If a candidate freshly registered in Round-2 is not allotted a seat, he/she can participate in Round-3 without deposition of Security Amount.
- However, if a no change / upgraded candidate does not want retain seat, he may exit with forfeiture of security amount.
- In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the allotted seat shall be cancelled and the security amount shall be forfeited.

#### Note: -

- The choices filled by the candidates for the Round-1 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Round-2.
- The above instructions should be read in accordance with Govt. of Haryana notification dated 08.08.2025 and public notices issued from time to time.

- Any admissions made by any private Nursing/Paramedical/Physiotherapy institutes (affiliated to Pt. BD Sharma UHS Rohtak) in the state at its own level shall not be valid and such admission shall be considered as null and void.
- All candidates should ensure to upload all requisite documents on the Admission Web Portal and complete the registration process as per schedule.
