**A CANDIDATE MUST HAVE THE FOLLOWING QUALIFICATIONS.**

1. Must have passed M.B.B.S from a Medical College/Institute recognized by the NMC.
2. The internship must have been completed on the last date of application.
3. Permanent registration certificate from Haryana Medical Council. The candidates, who passed the MBBS & completed the internship recently and are not registered with Haryana Medical Council, may submit an affidavit that they will apply for registration in Haryana Medical Council and submit the Haryana Medical Council Certificate within one month of the date of joining, failing which they will not be paid their salary and their service may be terminated without any notice. The candidates, who have registered in any other State Medical Council must submit the NOC certificate along with the proof of application for Permanent Registration in Haryana Medical Council.

**NOTE: - ON FOLLOWING TERMS & CONDITIONS: -**

1. The selected candidates will have to deposit the security as 50% of the basic salary, which is refundable security for each session exclusively and separately for the House Job. The selected candidates who fails to deposit the security money, their appointment will be cancelled without assigning any reason.
2. The candidates who remain absent willful for more than 07 days, his/her services shall be terminated and no opportunity will be allowed for re-joining during that session.
3. Incomplete application forms will not be entertained and will be rejected.
4. That the resignation tendered by the House Surgeon will be considered, if there is any genuine reason with 15 days advance notice or after depositing 15 days salary.
5. The security money deposited by the House Surgeon who leave the session before the end of the session will be forfeited and No Experience be issued in that case.
6. The other terms & conditions will remain the same as provided by the prescribed proforma of the application form.
7. The vacancies falling vacant and on account of resignation /termination etc. will be displayed on the notice board as well as the website of institute.
8. These vacancies are liable to increase and decrease
