## IMPORTANT NOTICE (Advt. No. 02/2019)

It is hereby notified for the information of all concerned that the allotment of posts at PGIMS, Rohtak and Govt. Medical Colleges through counseling will be done as per the schedule given hereunder, in order of merit of total marks obtained out of 100 marks, prepared on the basis of 90 marks of written/ screening test and out of total 10 marks awarded as per Socio Economic Criteria, during the course of document verification. The Counseling will be conducted in order of merit of eligible candidates in respect of the candidates who have applied for the post of Staff Nurse against Advt. No. 02/2019 and subsequent Public Notice/ Corrigendum dated 20.11.2020 and whose documents verification have been done on 07.12.2020 - 12.12.2020, 17.12.2020 & 15.01.2021. Any authorized person/ relative on behalf of the candidates will not be allowed to attend the counseling.

## NOTE:

- 1. The list of candidates required to appear in counselling on above mentioned dates shall be uploaded on the University website shortly.
- 2. The counselling for the posts lying vacant after the allocation of colleges on 08 & 09.02.2021 will be done on 10.02.2021. For this purpose, the list of the candidates will be uploaded on the University website on 09.02.2021 after 7:00 PM.

The following procedure will be followed for holding the counseling:

- 1. The candidates are directed to report for counseling in the Administrative Block of the University at 9:00AM sharp as per the schedule notified on the University Website (www.uhsr.ac.in).
- 2. General Terms and Conditions of the Advt. No. 02/2019 and the Public Notice/ Corrigendum dated 20.11.2020, shall be applicable for filling up the posts.
- 3. Videography of the entire counseling process will be done, Biometric Attendance of the candidates will be taken. Vacancy position will be displayed on the projection screen continuously. Signature of each candidate with date and exact time will be obtained on the post allotment sheet.
- 4. The posts will be offered to the candidates in PGIMS and various Govt. Medical Colleges through physical counseling directly in order of merit. It is clarified that the physical presence of the candidate at the time of counseling is MANDATORY.
- 5. If the candidate is not physically present then his/her name will be announced thrice, thereafter the post will be allocated to the next available candidate in order of merit. If a candidate comes to the venue of counseling after allotment of post in that category is completed then his/her candidature will not be considered.

- 6. Where there will be a tie of marks in merit, the tie will be broken by following the criteria already advertised and in order of the steps given hereunder:
  - Age: A candidate who is older in age may be considered senior to the candidate having identical score in order of merit.
  - ii. Marks: A candidate having more marks in written test of 90 marks may be considered senior to other candidate having lower score.
  - iii. If the tie still persists then marks of his/her qualifying examinations may be considered for the purpose.
  - iv. The tie even if still is not broken then the marks obtained in the Matriculation may be considered for breaking tie.
- 7. As soon as the posts of Staff Nurse for any category/ in any Govt. Medical College is/are filled up, the counseling for that category/ Govt. Medical College stands closed.
- 8. For the post of Staff Nurse, category-wise common waiting list for PGIMS and all Govt. Medical Colleges will be prepared.

## Note:

- 1) As already notified in the advertisement the Selection List (category-wise), except Pt. B. D. Sharma PGIMS, Rohtak, shall be forwarded to the Govt. to issue appointment letters to the selected candidates. Appointment Letters to the candidates who have been selected for PGIMS, Rohtak will be issued by the University of Health Sciences, Rohtak.
- 2) Please note that option once exercised for allotment of a College/Institute shall be final and no shifting will be allowed in any case.
- 3) All the appointments made in the Govt. Medical Colleges/ PGIMS, Rohtak shall be subject to the final outcome of CWP No. 13789/2019, CM-11760-CWP-2020 in CWP-13789-2019.
