## QUALIFICATIONS & EXPERIENCE

1. MBBS from any Institution/University recognized by the NMC.
2. MD/MS/DNB in the subject concerned. In case the candidates having MD/MS qualifications are not available, the candidates having diploma in the subject concerned or training experience of 3 years as PG student in the subject will be considered for appointment.
3. Must be registered under the State/Central Medical Registration Act.

### Age

Not less than 22 years and not more than 40 years upto closing date.

-The benefit of relaxation in upper age in respect of candidates belonging to SC/ST, BC, ESM etc. will be as per Haryana Govt. instructions issued from time to time and is restricted to Haryana Domiciles only.
