

**Pt. B.D. Sharma, University of Health Sciences, Rohtak**

**Notification**

The matter regarding enhancement of remuneration of assessment/ inspection teams, enhancement of inspection fee from private affiliated College and charging of inspection fee from the affiliated Government Colleges was placed before the Academic Council vide its Agenda Item No. 21.18 held on 26/07/2024 and further before the Executive Council in its 53<sup>rd</sup> meeting held on 30.10.2024 vide Agenda Item No. 53.19. Finally, the Executive Council resolved to approve the recommendations, of the Academic Council with the direction to circulate these guidelines to all affiliated Government/Private Colleges.

Following the approval of Executive Council, the amendments in the Ordinance Regarding Conditions of Affiliation of Colleges & Institutions to the privileges of the University and the withdrawal of such privileges are hereby notified as under for its implementation with immediate effect:-
